COUNTY FAIR 21 connenced at 150500H when A Company, ist Bn, 9th Marines reinforced with two platoons of C Company, 1st Bn, 9th Marines surrounded LE SON (3), vic (AT 970645). At 150740H, elements of the 4th Bn. 51st ARVN Regiment entered the hamlet for the search and clear portion of the operation. By 151200H, the operation had yielded four VC KIA and four VC captured along with three individual weapons, one rifle, MAS 36, one carbine, US, and one rifle, M-14. One rifle grenade and several M-14 and carbine magazines along with cartridge belts were also captured. Fifty civilians were moved into the collection point where shelter, food and medical care were available. An I Corps Audio-Visual Team was on hand to assist the HOA LOI Village PAP personnel in the psywar effort. #### C. COMMANDER's Evaluation.

The Operation was very successful from the VC casualty point of view. However a few problems were encountered on the tactical movement to the area and on the PSY-Wer side of the operation.

In moving toward the objective, the number of flares in the area caused movement of the rifle companies to be extremely slow. Also the fact that the Ompany Commander of one of the companies was not able to recon the area from the air resulted in some confusion in finding the objective on the ground. It is recommended that an aerial recon of the objective area be made in the future.

It was believed prior to theoperation that the ARVN would keep close control on the population and that they would handle a large part of the PSY-War effort. This however, proved not to be the case. In the future the Marine PSY-WAR officer will play a larger part in the direction of the PSY-WAR effort.

The enemy contacts were all made on the first day. This seems to be the pattern as this was also the case in the last COUNTY FAIR conducted by this battalion. It is recommended that future operations be one day in length or have another objective area for the second day.


